Reeve Wilson called the Public Hearing for Application 022-16 to order at 1:56 p.m.

Development Officer Chisholm presented Application 022-16 submitted by Laurie and Janice Butler to construct a 6 ft. x 6 ft. chicken coop and 8 ft. x 6 ft. chicken run to accommodate 12 chickens for personal use on Lots 8-14, Block 130, Plan 5659X, in the Hamlet of Parkland which is a Direct Control District.

Development Officer Chisholm stated that adjacent landowners were notified of the development application and no comments have been received.

Development Officer Chisholm advised the applicant proposes a wire mesh fencing to keep predators out and will store chicken feed in plastic containers with lids.

Development Officer Chisholm stated Parkland is a Direct Control land use district and all applications for development must be referred to the municipal Council for a decision.

Development Officer Chisholm advised the applicant requested the \$150.00 application fee be waived and they be charged the permitted fee of \$50.00, resulting in a refund of \$100.00.

Development Officer Chisholm presented the recommended conditions if the application is approved.

Mike Burla asked if roosters would be a problem.

In consideration that, despite investigations into contamination of water and soils and Environmental Site Assessment(s) in the Hamlet of Parkland, the potential exists for contaminated water or soils to be present on the property, now or in the future, and therefore development on the property has additional risks, and insofar as those risks must be accepted by the applicant and future property owners, the following conditions shall apply in respect of potential contamination:
 - a. The developer/landowner shall assume all responsibility for development of the property;
 - b. The developer/landowner shall assume responsibility for all conditions existing on the site;
 - c. The developer/landowner shall assume responsibility for any clean-up of the property;
 - d. The developer/landowner shall assume responsibility to ensure no escapage occurs onto neighboring lands.
- 2. The Municipal District shall not be liable, either directly or indirectly, for any damage, injury, or consequential loss, or damages for pure economic loss or other costs or inconvenience however caused from the development of the property;
- 3. The property shall be kept in a neat and orderly manner;
- 4. Except for fences seven (7) feet or less in height, there shall be no development within 6.1 meters (20 feet) of the front and rear yard property boundaries or within 3 meters (10 feet) of the side yards, unless a development permit is obtained that specifically varies the required setback to allow the development.
- 5. Maximum of one (1) rooster on the same parcel of land.
