# 5. **EMERGENCY SERVICES**

# (a) M.D. Emergency Management Plan

Emergency Services Manager Coleman provided a brief review of the M.D.'s Emergency Plan as information. He advised the Emergency Plan is updated yearly and he has not had a committee meeting since the flood. He advised he has been meeting with the staff and doing Incident Command System (ICS) training.

Councillor Sandberg asked what the purpose of the Emergency Management Committee is if they don't meet or review the Emergency Management Plan.

He said a review of the Emergency Management Plan was done with the entire Council after the flood but it hasn't been done lately.

Emergency Services Manager Coleman stated he would do an update with Council after the election.

#### (b) Granum Fire Works on Canada Day

Emergency Services Manager Coleman advised that Kelly Starling and himself provide Safety Codes Officer investigations and inspections for the Town of Granum. He advised he has signed off for the Granum Canada Day fireworks for the last 14 years and the company provides proof of insurance to him. He asked for Council's approval. He advised the site plan meets all the setback requirements.

Moved by Councillor Kroetsch that Emergency Services Manager Coleman, acting Safety Codes Officer, be authorized to sign off on the Granum Canada Day fireworks.

# (c) Alberta Health Services – Dispatch Issues

Emergency Services Manager Coleman provided an overview of the increase in medical first response call volumes and advised that Reeve Hemmaway, Kelly Starling and himself met with the local reporter and will be doing an interview with CBC in the near future. He advised AHS dispatch is an issue as the fire departments are not being dispatched at the same time as the ambulances.

CAO Vizzutti advised the new dispatch system and the lack of communications is creating problems for the fire departments. She advised there are variations on ambulance agreements throughout this province that do not require the M.D. to be a full-fledged ambulance provider. She said the agreement authored by the M.D.'s lawyer has been used by other municipalities in the province.

Councillor Wilson feels the Minister is now getting information from AHS that the M.D. first responders are showing up later than the ambulance. He said it is the system that creates that situation whether it was purposeful or not. He said AHS is not pleased with the capabilities the M.D. displayed which seemed to be a threat and this is a way to show the Minister the M.D. first responders are inept, when they are not.

Councillor Sundquist asked what the M.D. can do to get things done and provide the best service to ratepayers.

# (d) Moon River Estates Water Plant – Piping

CAO Vizzutti presented 2 quotes for stainless steel re-piping upgrades in the Moon River Estates water treatment plant as follows:

Simpson Plumbing - \$18,884.00 plus GST

Parcon Construction Ltd. - \$27,937.00 plus GST

Moved by Councillor Wilson the quote from Simpson Plumbing, in the amount of \$18,884.00 plus GST, for re-piping using stainless steel at the Moon River Estates water treatment plant be approved.

CAO Vizzutti will provide a tax study for Moon River Estates to recover the cost of re-piping, beginning in 2018.

#### (e) Willow Creek Park - Well

Superintendent of Public Works Johnson advised the steel pipe in the well at Willow Creek Park is corroded and causing the pump to burn out. He presented an estimate of \$7500.00 from Uhl Drilling to drill a new 65' deep well beside the old well.

Moved by Councillor Van Hierden to authorize Superintendent of Public Works Johnson to hire Uhl Drilling to drill a new 65' well at Willow Creek Park at a cost of \$7500.00 and funds be transferred from reserves.

# (f) Elected Officials Training

CAO Vizzutti advised the Elected Officials Education Program will be hosting Munis 101: The Essentials of Municipal Governance in the 90-day period following the upcoming municipal election. Munis 101 will meet the mandatory training criteria introduced under the amended Municipal Government Act.

# (g) Alberta Energy Regulator – Re: Lexin Resources Ltd.

CAO Vizzutti presented a letter from Alberta Energy Regulator advising they have been working to resolve the legal challenges related to the Lexin Resources Ltd. insolvency. She advised the M.D.'s legal counsel from Brownlee are handling the bankruptcy on our behalf and the M.D. has been lobbying Municipal Affairs to get legal standing in Legislation to be number 3 on distress warrant tax property. The Alberta Energy Regulator suspended the licences of all Lexin's wells, facilities and pipelines. The AER is holding community meetings at the end of June, in Vulcan and Cayley, to provide information and answer questions from landowners and community members. The Surface Rights Board, the Farmers' Advocate Office, and Orphan Well Association will also be in attendance.

# (n) Recreation Planning Committee Meeting

Deputy Reeve Alm reported on the Recreation Planning Committee meeting he attended on June 21, 2017. He advised Parks and Environment will have a plan ready for August and it appears to include garbage collection, dumping stations, random camping nodes and signage kiosks to inform people what they can and can't do. He advised that he stated very clearly at the start of the meeting, the M.D. wants to see some thresholds and carrying capacity established prior to building any infrastructure. He advised the next meeting will be held on July 12, 2017 in Ranchlands which was to be the final meeting however, they are planning another meeting in August. He advised the July 12<sup>th</sup> meeting conflicts with the M.D. Council meeting.

Deputy Reeve Alm advised Parks and Environment stated that some municipalities may want to improve their local road system to accommodate the additional traffic travelling to and from the Porcupine Hills and Livingstone Range. He advised it affects the M.D. of Willow Creek on Beaver Creek Road, Flying E Road and Lyndon Creek Road but not as much as the MD of Ranchland as we have Highway 520 which is a Provincial Highway. He told the committee the M.D. of Willow Creek will not be upgrading the roads leading into the recreation areas. He explained the developer is required to upgrade the road and in this case it would be the Alberta government. He explained the impact on emergency services with the increased number of people using the area.

Moved by Councillor Sandberg that Deputy Reeve Alm be authorized to attend the Recreation Planning meeting on July 12, 2017 and not attend the Council meeting.
