(a) MD of Willow Creek Property for Sale - Lot 1, Blk 1, Plan

Manager of Planning and Development Services Gibeau and CAO Vizzutti presented a concern with the current access road in the SW 31-10-24-4 and NW 31-10-24-4 not being within the limits of the registered road plan. (e) Airport Water, Sewer & Garbage Rates

CAO Vizzutti provided information regarding the Memorandum of Agreement and Servicing Agreement with the Town of Claresholm to provide water, sewer and garbage to M.D. ratepayers at the airport. She advised the current formula used by the Town of Claresholm is not an option for the M.D. She advised if the M.D. recovers all the costs their rates would double.

Discussion ensued.

CAO Vizzutti said she would provide a utility cost recovery report for 100% and 50% recovery of the amount the Town of Claresholm charges the M.D.
